
Jan Albert, Vice President of Human Resources





Foster Care and Kinship Services



Foster Care

KID Foster Care grew tremendously, showing an 18% increase in capacity. The largest provider in both counties, KID Foster Care served 350 children in Broward County and 207 children in Palm Beach County.

In addition, the Broward County and Palm Beach programs were integral in creating 41 new Forever Families by facilitating adoptions into loving families. The past year was full of heartwarming stories like the adoption of two medically fragile children, and the adoption of a little boy into a family who had previously adopted his two siblings.

Kinship

In the past eight years, the KID Kinship Program has evolved into a comprehensive continuum of care and was integral in stabilizing 99% of families, keeping the children served out of the dependency system.

Earlier this year, KID recognized a gap in support for Kinship Families in Broward County in two key areas: general programs in South Broward and access to legal services. Thanks to an increased funding allocation from Children's Services Council (CSC) and a strengthened partnership with Legal Aid Service of Broward County, Inc. and the Memorial Healthcare System, KID Kinship is poised to serve an additional 267 families during the 2013-14 contracted year.

A growing need for loving foster parents: In three years, the number of children removed from home has increased more than 27% in Palm Beach County and 23% in Broward County.

Family Strengthening

KID FIRST

At KID First 94% of our families successfully completed all goals of the program, exceeding the 80% contractual standard. The team's dedication and compassion did not go unnoticed; 191 of 225 family surveys keep indicating that the families were "always" or "most of the time" satisfied with the services they received.

KID Healthy Start

KID Healthy Start served 1,434 families this fiscal year and initiated several educational outreach programs in the community. Since February 2012, the smoking cessation program, in conjunction with the March of Dimes, has exceeded expectation serving more than 400 individuals. In addition, KID Healthy Start hosted group events, support groups and expanded its community presence by partnering with other organizations such as the Jack & Jill Children's Center in Fort Lauderdale, Florida.

KID Homebuilders®

KID HOMEBUILDERS® celebrated a milestone this year: the program helped support 108 children in imminent danger of removal from the home. Understanding the emergent nature of these situations, KID HOMEBUILDERS® staff members met with 106 of the families within 24 hours of referral to the program.

KID Healthy Families

KID Healthy Families served 135 families through a variety of educational programs including group discussions on smoking cessation and shaken baby syndrome; hosted forums in partnership with KID Healthy Start on topics including unhealthy relationships and good oral hygiene, and provided activities like face painting to teach positive interactions with kids.



Healthy Start and Healthy Families Make a Difference: Between 2010-2012 84% of mothers in Broward County initiated breast feeding as compared to only 80% statewide; and 2.1% of children in Broward County were born to mothers who reported smoking while pregnant as compared to 6.8% statewide.



Therapeutic Services

KID Safe Visitation

The only accredited visitation program in Broward County, KID Safe Visitation provided safe visitation and therapeutic visitation services to 60 children. During an audit from ChildNet, KID Safe Visitation achieved 100% in all evaluation areas including metrics such as “parents with a history of abuse exhibiting non-violent behaviors during visitation” and “children remaining free from abuse and neglect during visitation.” A standout program, KID Safe Visitation has been recognized by other agencies and by the family court as the standard of service for parent-child visitation.

Coordinated Family Services

This year Coordinated Family Services (CFS) achieved 100% in all evaluation areas during an audit from ChildNet. Their immense success with the families resulted in an increased interest from the community, resulting in a 4-8 week waiting period for individual and family therapy services.

In December, CFS hosted a holiday event with program partner Broward Addiction Recovery Center (BARC). Current and former program participants were invited to speak about their struggles and achievements and the positive impact CFS has had on their families.

Family Counseling Center

During the year, the Family Counseling Center (FCC) solidified and developed relationships with Hispanic Unity, the Broward County School Board, and HANDY to increase referrals and provide better care to the community. Through these coordinated efforts, FCC provided support to 550 children, and reported solid outcomes including:

- 97% of families made significant progress in treatment plans
- 86% of families displayed improved family functioning
- 87% of families reported resolving problems on their treatment plan

Excellence is part of the culture: 100% of client satisfaction surveys returned to KID about the Family Counseling Center provided positive feedback about the work of the KID child and family therapists.

Educational Services



KID Preschool PLUS

KID Preschool PLUS underwent a dramatic change during the fiscal year as the team expanded with the addition of teachers and teacher assistants, the improvement of the campus experience with fun and vibrant “classroom makeovers,” and a reinforcement of its curriculum with new ideas and creative ways to learn. These early childhood education investments helped KID Preschool PLUS double in size, growing from 37 enrolled children in 2012 to 73 enrolled children in 2013!

MOST Aftercare/ Summer Camp

The MOST Aftercare and Summer Camp programs thrived like never before thanks to recruitment efforts and new activities that kept kids engaged, interested, and coming back for more! Students tended and harvested their own food in the KID vegetable garden, let their inner thespians take center stage during a Fort Lauderdale Children’s Theater production of Aladdin, and practiced their serve during Tennis Tuesdays at Hagen Park with Tennis Director, Donna Kocyba.



No rumbling tummies here! KID served 20,000 nutritious lunches at KID Preschool Plus and 50,000 healthy snacks to MOST Aftercare/ Summer Camp this year.



H.E.A.R.T.



After receiving the grant and green light to begin the H.E.A.R.T. program, KID attended the Kickoff Meeting in Washington D.C and filled the year with collaborating, planning, and scheduling training sessions for new members and for organizational partners. H.E.A.R.T. Alliance workgroups and subcommittees were developed and met regularly to develop the readiness assessment, plan the program components, develop the assessment/evaluation with Barry University, and strategize about communications. All the hard work culminated in the submission of the strategic plan and program operations manual in the first report to the Department of Health and Human Services (HHS).

Ancillary Services

KID Dental Clinic



At the KID Dental Clinic, the emphasis on education helps children learn that oral hygiene and keeping up regular visits to the dentist are important components of a healthy lifestyle. Since its inception in 2012, there have

been more than 5,000 patient visits to the clinic with an average of 25-30 kids treated per day. Thanks to a generous gift from Patriot National Insurance, the clinic is poised to expand and treat more children without insurance in the coming year.

The Eye Care Institute at KID



The Eye Care Institute at KID

The Eye Care Institute at KID serves a dual purpose: meeting the needs of children and families in the community and functioning as a hands-on educational environment.

Third- and fourth-year optometry students from Nova Southeastern University, under the supervision of NSU faculty members, learn using state-of-the-art technology while giving compassionate and comprehensive care to families in Broward County. Patients have the opportunity to browse and select from a wide variety of covered frames at a reduced cost regardless of insurance.


The Eye Care Institute at KID treated more than 1,300 children and families during 3,960 annual visits. Approximately 2,823 of those visits were children under the age of 18, many of whom had never had a vision examination.



“Filling” the Gap: According to the Pew Charitable Trusts *In Search of Dental Care* report Florida has the eighth highest rate of underserved children. In 2011, 76% of Medicaid-enrolled children in Florida went without regular dental care.


