Necessity is often the catalyst that elicits change, encourages growth, and drives us to pursue what we may think is impossible. During the last four years, KID redesigned the residential homes on our main campus by launching a family-style foster home initiative to serve sibling groups separated due to removal from their birth parents. Since that launch, KID has served 91 children and reunited 31 sibling groups.

The possibility for KID to serve more children through this initiative presented itself in the spring of 2018. With the support and guidance of our KID Board of Directors, we acquired the Kids In Distress West Campus, a 4-acre campus boasting two homes that could accommodate 14 additional children and nearly 4000 square feet of office space. In June, with the help from hundreds of volunteers including special teams from Lowe's Heroes, No Perfect People Inc., Suffolk Cares, Cushman & Wakefield, Carnival Foundation FUN TEAM, and an outpouring of financial support from our KID Board of Directors and the The Catherine L. and Edward A. Lozick Foundation, the impossible once again became possible, and we opened the two additional homes to foster children.

Our focus at KID remains constant – to provide a continuum of programs and initiatives that are fundamentally based on our core value of family. Our reach continues to expand through programs that are rooted in excellence, yet continue to evolve, reaching possibilities that we never imagined. You are the heroes who make this work possible for over 11,000 children each year. Thankfully, as a generous benefactor, volunteer, or community advocate you know that all children deserve more than what is just "necessary" – they deserve what we think is impossible – they deserve KIDpossible.
