Forty years ago a small group of concerned advocates courageously opened a six-bed shelter for the youngest victims of child abuse, abandonment, and neglect. Their vision, wisdom, and commitment to provide innovative, child-focused programs, while partnering and collaborating with community stakeholders, corporate partners and other human service organizations has been the sustained hallmark of Kids In Distress. Today, KID impacts over 20,000 children and their families in South Florida, with initiatives that span from Monroe to Palm Beach Counties. During the last year our regional movement to end child abuse and strengthen families took a major leap forward. We accomplish this by instilling a culture that always puts family first and consistently does whatever it takes to ensure that children are safe, healthy, and prosperous within their homes and in the childcare centers that we support.

Our success is measured one child, one family at a time, while we continue our unwavering ambition to fulfill unmet needs that continue to exist within our communities.
